# Facility Requirement

- For facilities with an area of  $\leq 750$  acres, measure angles of 30 degrees from the center point for a total of twelve 30 degree measurements evenly spaced ( $\pm 1$  degree).
- For facilities covering an area  $> 750$  acres but  $\geq$  to 1,500 acres, measure angles of 20 degrees from the center point for a total of eighteen 20 degree measurements evenly spaced ( $\pm 1$  degree).
- For facilities covering an area  $> 1,500$  acres, measure angles of 15 degrees from the center point for a total of twenty-four 15 degree measurements evenly spaced.
